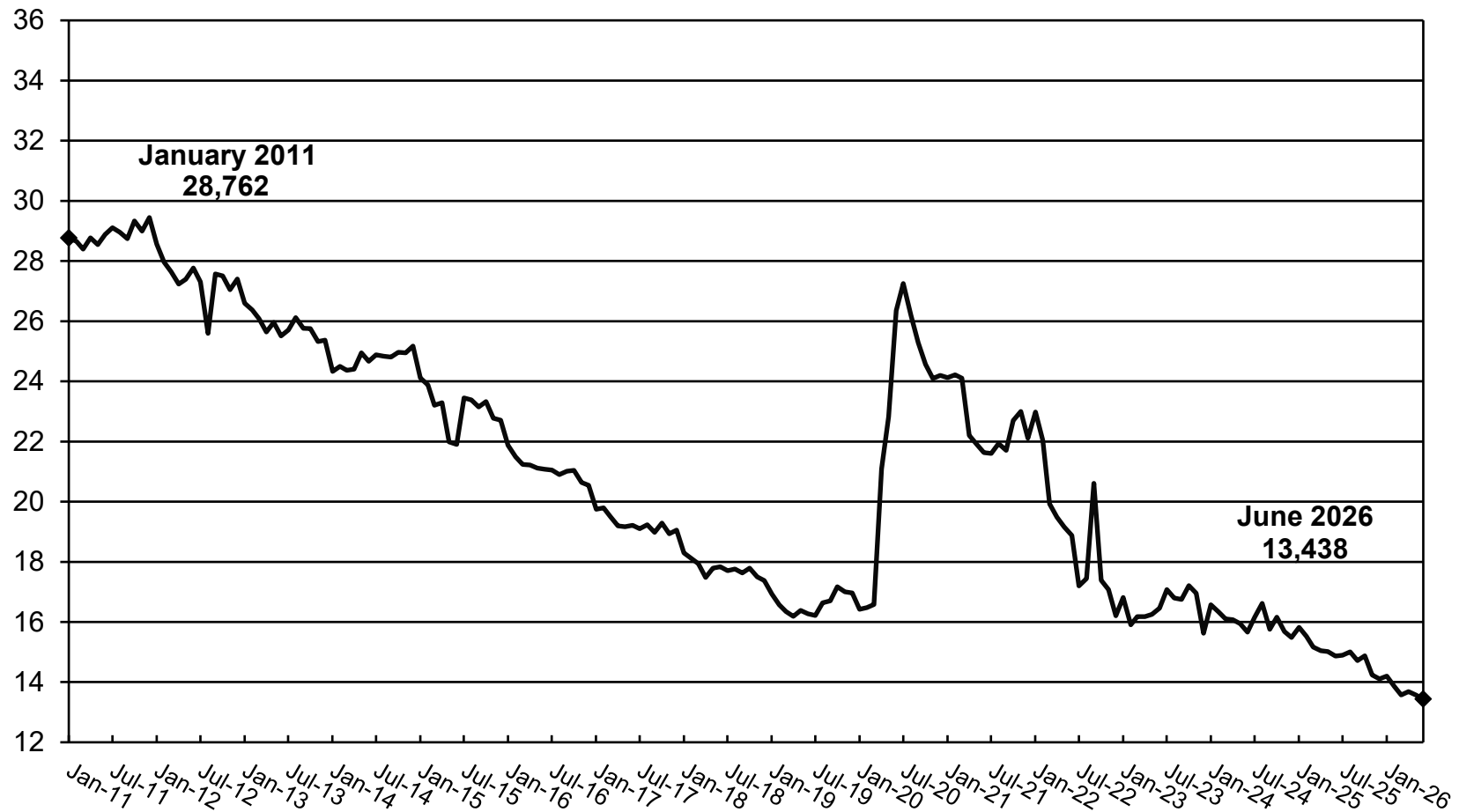

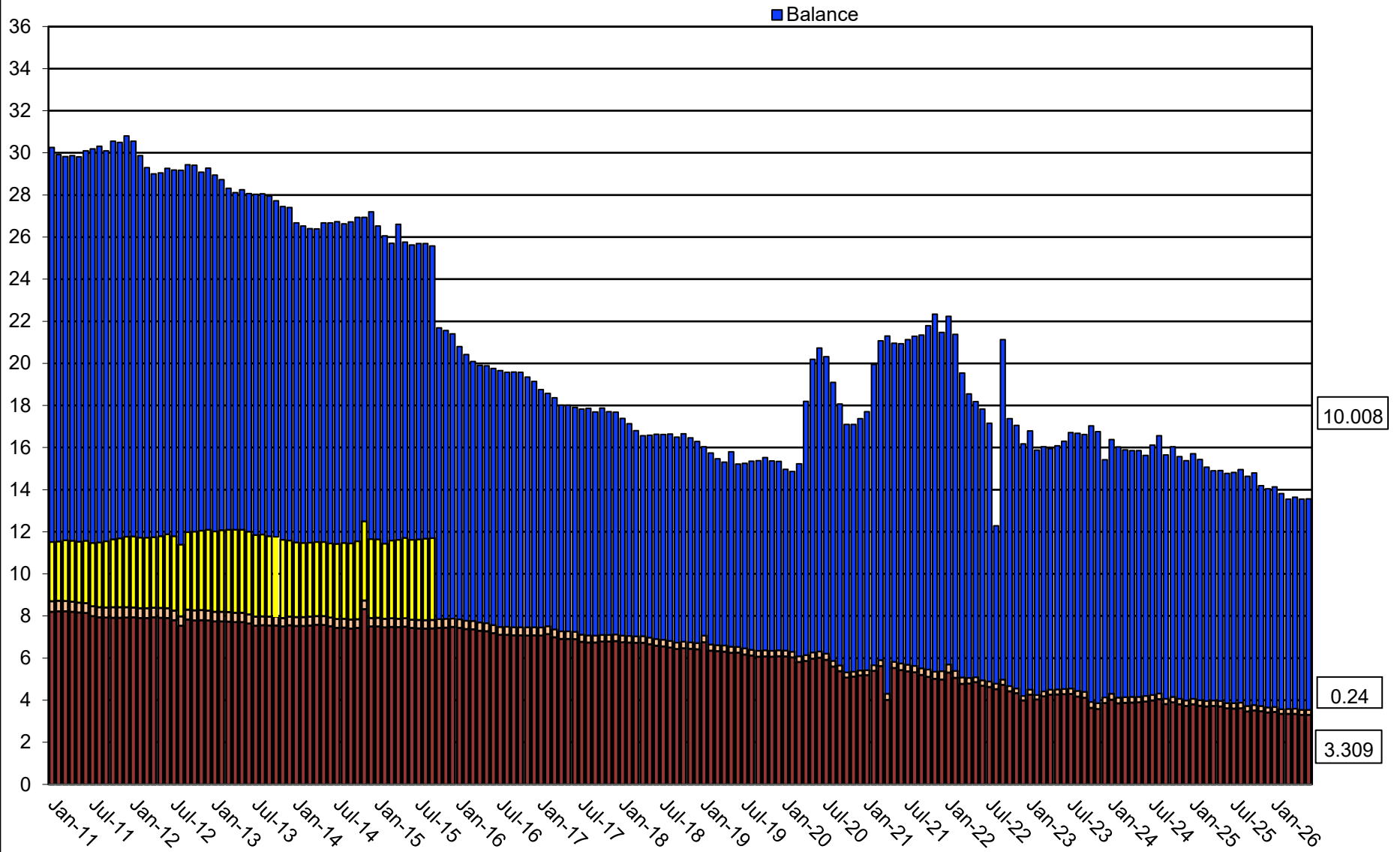

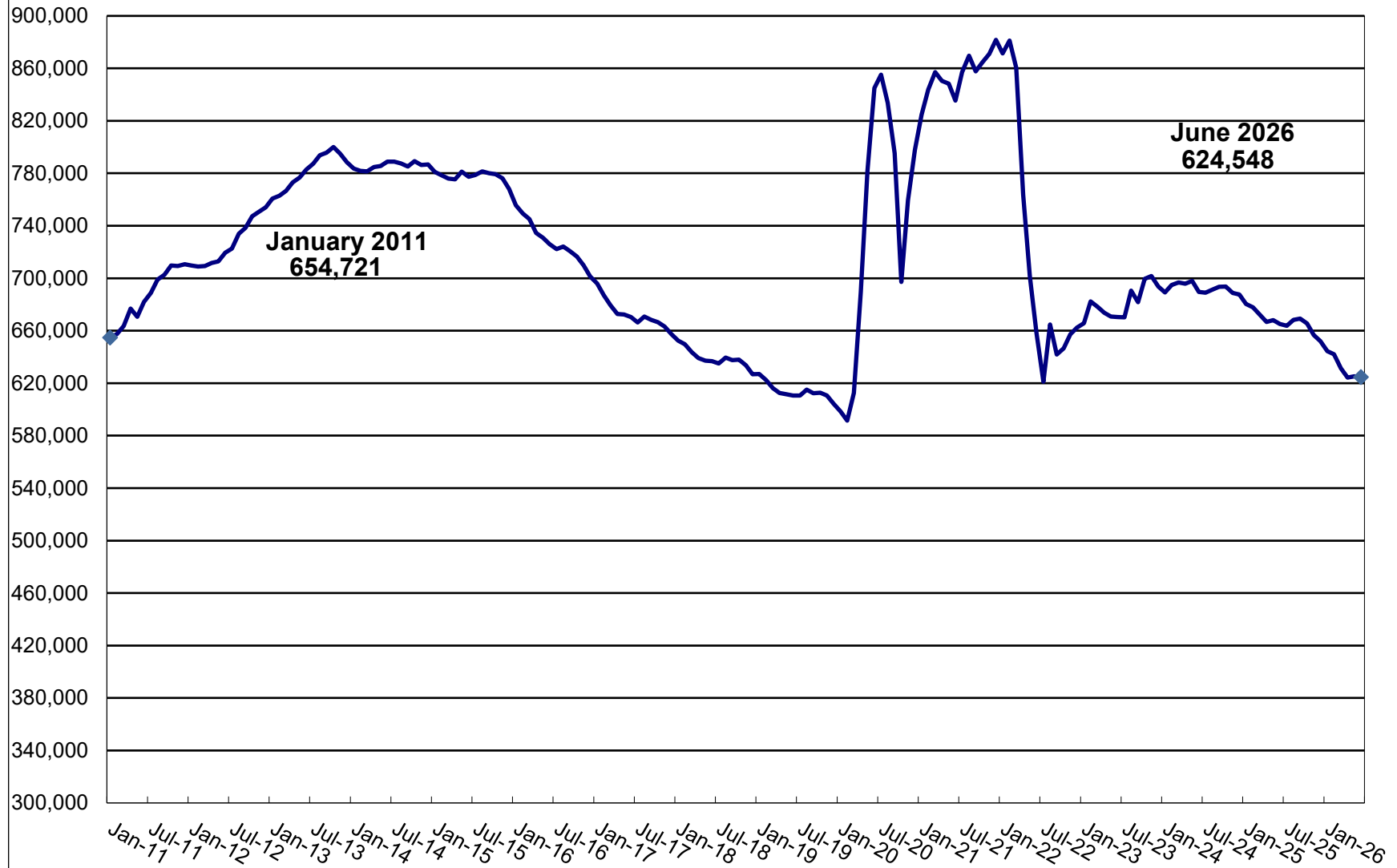

*Due to the 2025 federal shutdown, DHS provided the full \$50 supplemental SNAP benefit typically paid in partnership with the federal government to MSS recipients at the end of October 2025. November 2025 includes \$2,685,524 in state funds that were issued to make whole Marylanders who received only a partial SNAP benefit due to the shutdown. The state's typical share would have been \$706,902. P.L. 119-37, Section 118 provides that states shall be reimbursed for expenses that would have been paid by the federal government to continue carrying out the federal SNAP program. As of February 27, 2026, we have not received any formal guidance from USDA on how to submit for reimbursement of those state-issued SNAP benefits. DHS has been asking USDA to provide that formal guidance since November 2025. We will continue to work with USDA on securing the reimbursement of these funds.

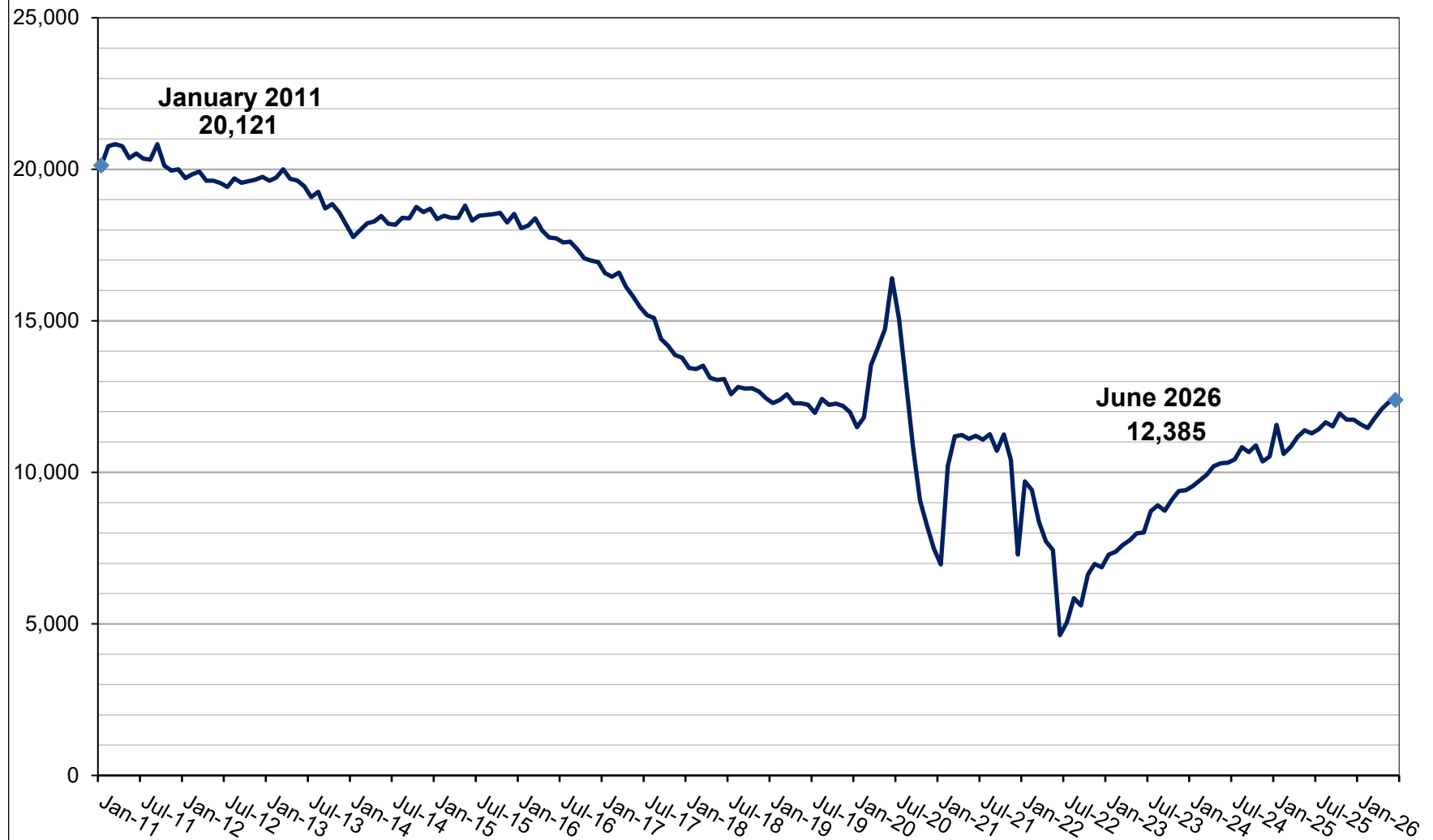
