#### **Benefit Amount**

Your household will receive a monthly benefit of \$40 for June, July, and August for each eligible child (\$120 total). If your household currently receives SNAP or TCA benefits, your Maryland SUN Bucks will be loaded on the existing EBT card (also known as Independence Card). If your household does not receive SNAP or TCA benefits, a new "Maryland SUN Bucks" card in your child's name will be mailed to you.

### **Important Notes:**

Maryland SUN Bucks benefits expire 122 days after their issuance date. Once they have expired, you will not be able to use them and they can not be reissued. If you receive Maryland SUN Bucks in addition to regular active SNAP benefits on an existing EBT card, Maryland SUN Bucks will automatically be used before your SNAP benefits since they expire first.

A household may not receive more than \$120 Maryland SUN Bucks per eligible child in 2024 or receive the benefit from more than one State. There are no circumstances whereby a household can use two separate benefits issued to the same child(ren). If you knowingly use duplicate benefits, you could be responsible for repaying the benefits, you or your children may lose benefits, and you may be prosecuted under applicable State and federal laws. If you believe your child may have received duplicate benefits, please call 1-800-332-6347 and select the option for Maryland SUN Bucks and destroy any duplicate SUN Bucks cards that you received. Only use benefits from the State where the child completed the 2023-2024 school year.

If you change your mind and no longer want to receive Maryland SUN Bucks benefits, you may opt out of the program by calling 1-800-332-6347 and selecting the Maryland SUN Bucks option.

### What if you disagree with our decision?

If you disagree with our decision, there are several things you can do. You can:

- 1. Call us at the DHS Customer Call Center at 1-800-332-6347 and select the option for Maryland SUN Bucks. Have this letter and your case number ready when you call.
- 2. Request a Fair Hearing. You have the right to ask us to review our decision at a fair hearing. Read the section on "Your Right to a Fair Hearing."
- 3. You have the right to reapply for Maryland SUN Bucks at any time.

### Will receiving Maryland SUN Bucks affect my family's immigration status?

NO. Receiving Maryland SUN Bucks will not affect your family's immigration status.
